

# The College of Pedorthics of Canada Policy for Admission of Foreign Trained Pedorthic Professionals

#### **Purpose**

This policy outlines the requirements, procedures, and conditions under which foreign trained professionals can apply for registration with The College of Pedorthics of Canada (CPC). It ensures compliance with national regulations and maintains the highest academic and clinical standards.

## Scope

This policy applies to all foreign-trained healthcare professionals seeking to become certified as a Canadian Certified Pedorthist C. Ped (C).

## **Eligibility Criteria**

Foreign-trained professionals must meet the following criteria to be eligible for consideration:

# • Three or Four year University Degree

To have your degree equivalency evaluated against Canadian standards, please visit the World Education Services Degree Equivalency website **HERE**.

# • English Language Proficiency

Applicants must demonstrate proficiency in English through CELPIP, IELTS, PTE Core, or an equivalent test unless the instruction of their previous medical training was in English.

# **Entry Paths and Requirements**

## 1. Direct Entry to Challenge CPC Written and Clinical Exams

For direct entry to challenge the CPC Written and Clinical Exams, a 3-year or 4-year undergraduate degree is required, as well as 8 equivalent pedorthic courses. To view the current list of 8 pedorthic courses required, click <u>HERE</u>.

## 2. Direct entry into the Western University Diploma in Pedorthics Program

For direct entry into the Pedorthics Program, a Kinesiology undergraduate degree is required.

## 3. Entry into the Western University Bridging Program

A 3 or 4 year degree in any area of study is required to enter the bridging program.

For options 2 and 3, once you have successfully completed the Pedorthics Program, you can attempt the CPC written and clinical exams.

#### **Decision Notification**

Applicants will be informed of the admissions decision via email. Decisions will be based on:

- · Academic credentials
- English proficiency

## **Appeals Process**

## 1. Reconsideration Requests

If an application is denied, the applicant may request reconsideration by submitting a formal appeal within 30 days of receiving the decision.

# 2. Review of Appeal

Appeals will be reviewed by the Admissions Committee, and a final decision will be communicated within 60 days.
